Construction Industry Joint Council Working Rule Agreement

With effect from Monday 30 June 2008 the following basic rates of pay, allowances and additional payments will apply:

WR.1 Entitlement to basic and additional rates of pay

Employers should note that if an apprentice is in the second year of training and aged 22 or over then the national minimum wage must apply. Currently the national minimum wage for an adult worker is £5.52 per hour and from 1 October 2008 is £5.73 per hour.

WR.21 (a) Death benefit £23,000

WR.21.3 Easybuild Pension Contributions

The minimum employer contribution shall be £5.00 per week. Where the operative contributes between £5.01 and £10.00 per week the employer shall increase the minimum contribution to match that of the operative, up to a maximum of £10.00 per week. For new entrants to the industry and re-entrants (job changers) who decline to make a minimum personal contribution of £5.00 per week then the employer will also make no contribution.
